## SERA - The single European Railway Area - The starting point



- The European Union adopted a law addressing the lack of competition, poor regulatory oversight and low levels of investment that have long hampered the development of an efficient and coherent rail transport system across Europe:
- Directive 2012/34/EU of the European Parliament and of the Council of 21 November 2012 establishing a single European railway area (recast)

## The 4<sup>th</sup> Railway Package - the next step to complete SERA



Removal of administrative and regulatory barriers; full market opening; effective enforcement of EU legislation

More effective separation between infrastructure management and rail service provision

Strong Regulatory Bodies ("market authorities")

Strong European Railway Agency ("system authority")

More interoperability and improved safety





#### **Technical Specifications for Interoperability**

- The European Union Agency for Railways (ERA) is driving the technical harmonisation of the European railway network
- The European institutions (EC & ERA) and the MS arte working on the reduction of national rules
- Long term goal: Defining a single target system for SERA (e.g. a single overhead contact line geometry)

## CER's role & activities in the field of regulation



#### CER

- CER actively contributes to the work of the ERA Working Parties and the work on the TSIs
- CER is a member of the EC Expert Group "4<sup>th</sup> RP TP" and gives input to the work on the secondary legislation (IA & DA)
- CER is a member of the ERA MGT Board and monitors the Agency's activities
- CER is an acknowledged interlocutor for the European Commission

### **SERA and research**



#### Research & Shift2Rail

- A single target system for SERA will require research in some areas
- The definition of single parameters shall be based on a sound technical assessment as well as an impact assessment.
- In other areas research will support the harmonisation: e.g. noise

## CER's role & activities in the field of research



#### CER

- CER/EIM/UIC strongly support the continuation of the successful Shift2Rail Joint Undertaking
- CER has been contributing to the work of ERRAC and the ERRAC vision 2050
- CER promotes a stronger role of the railway operating community in Shift2Rail2
